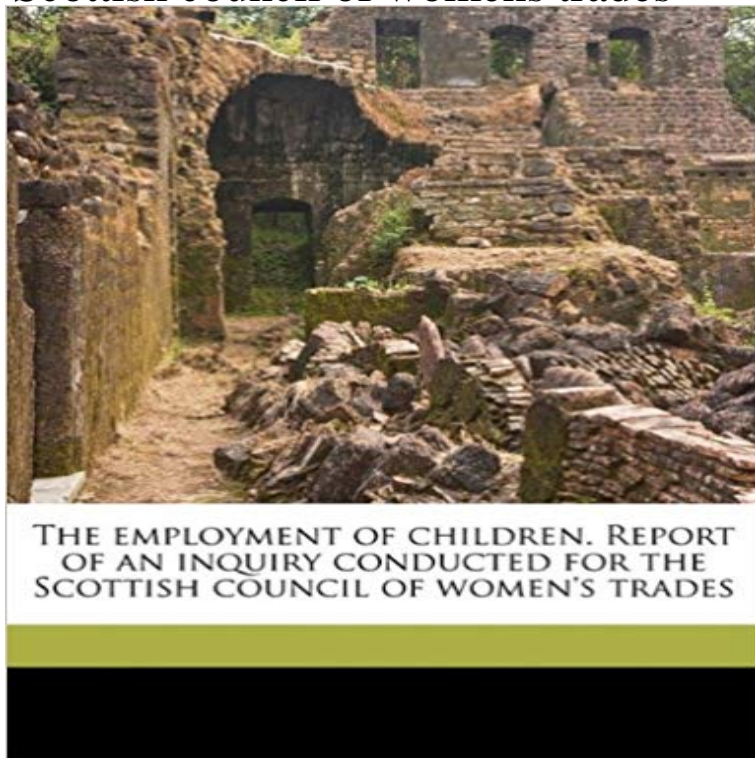


The employment of children. Report of an inquiry conducted for the Scottish council of womens trades
