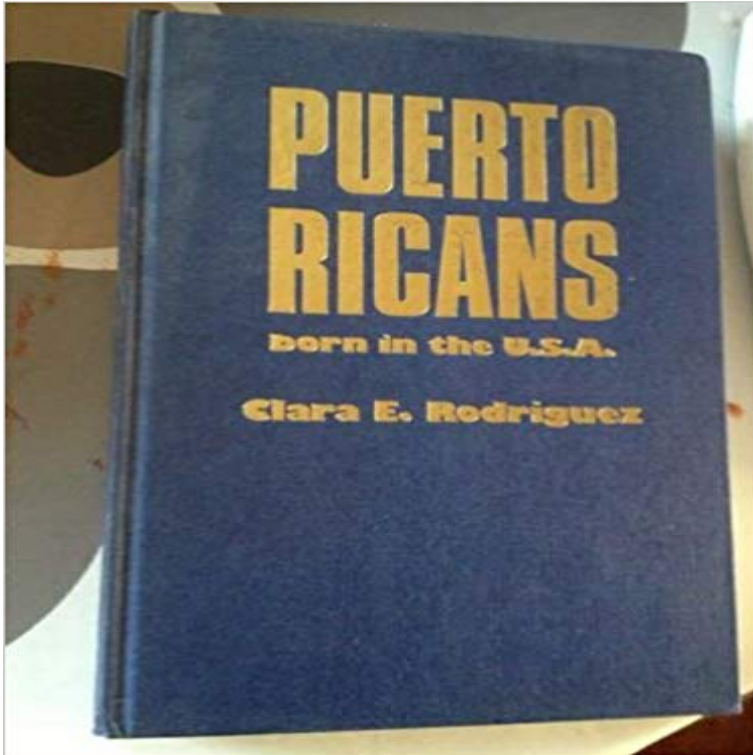


## Puerto Ricans: Born in the U.S.A.
