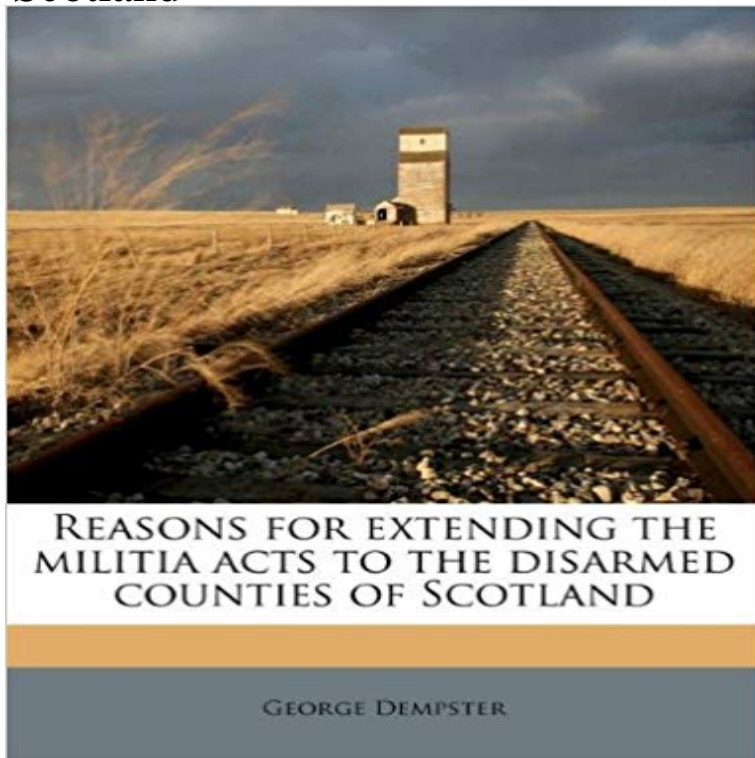


Reasons for extending the militia acts to the disarmed counties of Scotland
